For aged 3 years old and above: Uniform fee ( 2 sets of school uniform + 1 set of sports wear) = RM200

**Terms & Conditions**

- 1) School Fee is strictly by term (every 3 months). In the event, a child is enrolled in between of the months, the fee payable is also by 3 months.  
Example 1: Enrol in February 1st, 2014 (scenario is applicable every year)  
 Fee payable for EE 1 without lunch is still RM3,580 which is from February 1st to April 30th, 2014. Then, in March 2014, the school will issue an invoice to the same parent/s for the balance of Term 2 Fee which is RM1,850 (May Fee + June Fee and Term 2 Material Fee). This invoice will be due by March 25th to realign the term again. Please note that Material Fee will not be prorated.  
Example 2: Enrol in any time of August OR September 2014 (scenario is applicable every year)  
 Fee payable for EE 1 without lunch is from August to December 2014 (5 months) and if enrolled in September would be from September to December 2014 (4 months)
- 2) No refund policy for those who have paid and programme has commenced.
- 3) 50% refund is allowed for those who has registered and paid the full amount but program has not begun.
- 4) ALL fees paid are strictly non-refundable and non-transferable.
- 5) Deposit is refundable upon giving the school 60 days of written notice which is **two months prior to your child's intended last day**. For example: If you intend to withdraw your child from the school on 30th June 2014, you need to give the written withdrawal notice to the school by 30th April, 2014 in order to get your deposit of RM500 refunded otherwise it will be forfeited. Any other fees will not be refunded.
- 6) Stricly NO Deferment of term commencement upon confirming month of joining and fees paid.
- 7) Freezing of a term: Parents are only allowed to freeze one term (3 months) between Term 1 to Term 3. STRICTLY No freezing of term is allowed for term 4 (October to December). In the event if any current parents freeze term 4, they will need to pay Registration fee and insurance fee for the following new year again and deposit will be forfeited. Parents need to give 60 days written notice to the school before any freezing commences. Failing to inform the school about the freezing, the deposit will be forfeited. For example, if the parents wish to freeze Term 3 (July to September) of Year 2014, parents need to provide written notice to the school by April 30th, 2014.
- 8) In the event your child misses school, term break or any closure(s), there is no replacement of classes nor refund nor discount/rebate in fee. Parents are encouraged to plan for holidays based on the school yearly holidays calendar.
- 9) Insurance Fee is based on the calendar year basis. In the event a child enters school and paid insurance in October 2014, the child needs to pay for the insurance fee on Jan 2015.
- 10) The management reserves the right to revise the fee at any time with 1 month written notice to all existing parents.
